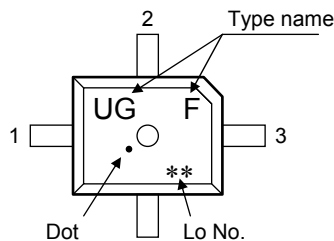

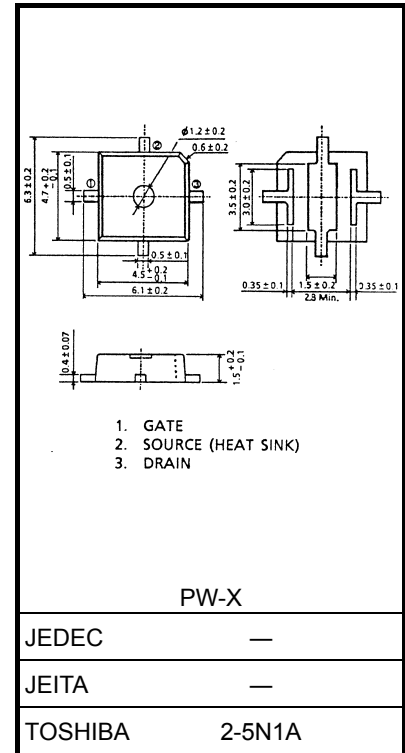


1. Gate

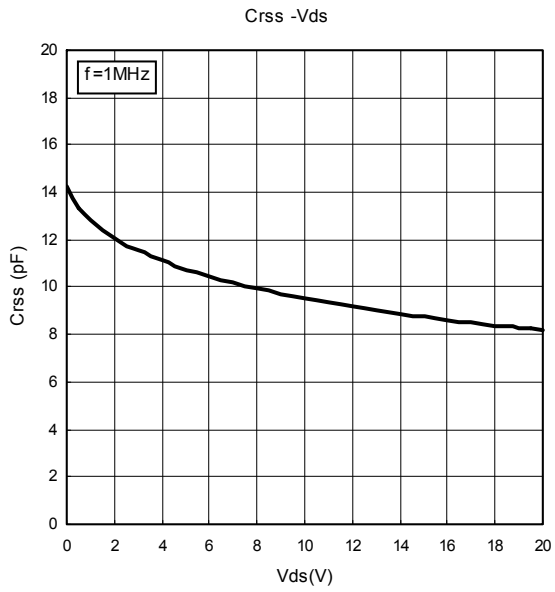
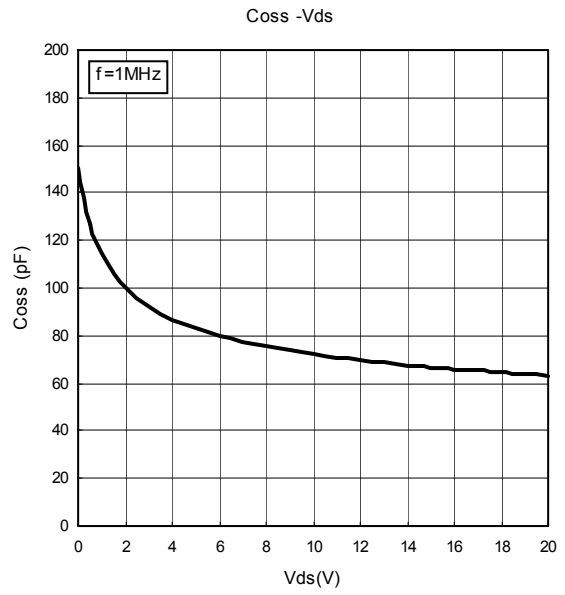
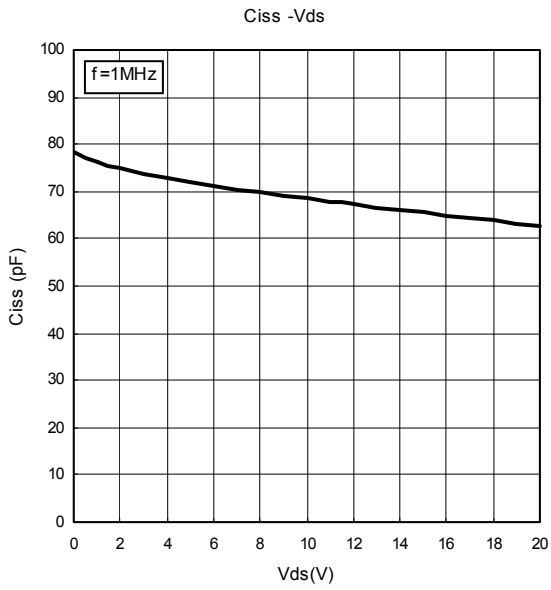
Output Power Test Fixture
